

Qoncier Terms of Service

Effective Date: September 22, 2025

These Terms of Service (“Terms”) govern your use of Qoncier (“we,” “our,” or “us”), including our app, website, and services. By creating an account or using Qoncier, you agree to these Terms.

Qoncier, Inc., an Illinois S-Corporation, is the entity providing the Services.

1. Purpose

Qoncier is an AI-powered health assistant to help track, manage, and share health information. It is not a substitute for medical advice, diagnosis, or treatment. Always consult a qualified provider.

2. Eligibility

- Must be 18+ to create an account.
 - Parents/guardians may create accounts for minors.
 - You must have legal authority to share the information you provide.
 - **Professionals** (including physicians, nurses, dietitians, trainers, and coaches) must only use Qoncier in accordance with their professional licensing and applicable regulations.

3. Account Responsibilities

- Provide accurate information.
 - Keep login credentials confidential.
 - Report unauthorized account use immediately.
 - **Professionals** are responsible for maintaining valid credentials and licenses, and must not misrepresent their qualifications on the platform.

4. Privacy & HIPAA

- Your use of Qoncier is subject to our Privacy Policy.
- We comply with HIPAA and safeguard your PHI.

- **Professionals** must comply with HIPAA and all applicable privacy laws when accessing client/patient data. Access is limited only to information users consent to share.

5. Acceptable Use

You may not:

- Use Qoncier unlawfully or in violation of HIPAA.
 - Interfere with app security.
 - Upload false or unauthorized data.
 - Share another's health data without consent.
 - **Professionals may not use Qoncier to solicit clients/patients from our platform or attempt to access users who have not explicitly connected with them.**

6. Data Sharing

- Users control who can access their information.
 - Sharing with providers, trainers, caregivers, or family happens only with explicit user authorization.
 - Permissions can be revoked at any time.
 - **Professionals agree to access and use shared data only for legitimate professional purposes, in line with the user's permissions.**

7. Service Availability

We strive for reliable service but do not guarantee uninterrupted access. Services may be suspended for updates, maintenance, or security.

8. Intellectual Property

Qoncier's content, software, and design belong to us or our licensors. You may not copy, modify, or distribute without permission.

15. Additional Professional Terms

 - Access to user data is limited strictly to what the user has authorized.
 - Professionals must agree to:
 - HIPAA Acknowledgment
 - Data Sharing Compliance Statement
 - Misuse of Qoncier, including solicitation of users or unauthorized access, will result in immediate account termination.
